1. There is no fee for this conference. Paper publication is free of charge.
2. According to the results of the conference, conference papers will be published and placed in the bibliographic database «Russian Science Citation Index» (RSCI).
3. The editorial team reserves a right for some minor proofreading of the papers submitted for publication and denial of publication of papers failing to comply with conference topics or meet the deadline and submission requirements.
4. All papers submitted are subject to the plagiarism test; the originality of texts should be no less than 70%.

6. The deadline for submission of papers is **May 1, 2021**. To participate in the conference, you should send the following documents by e-mail to **kafmen2016@yandex.ru** :
  - An application form for participation in the conference (see Annex A);
  - A research paper;
  - A license contract on granting the right for the use of the work (a license contract and instructions on how to fill it out will be sent to a participant after the paper has been accepted for publication).

**The paper is considered to be accepted for publication when the author receives a confirmation from the conference organization committee and fills out the license contract.**

### **Submission Requirements**

The papers may be written by one or several authors in Russian or in English.

The text should include the UDC (Universal Decimal Classification) code (mandatory) to be indicated before the title of the paper.

The papers are limited to 0,2 – 0,5 printer's sheets (3 – 8 pages). The text should be typed in Microsoft Word according to the following requirements:

- Automatic word wrapping;
- A4 page format, page parameters 210-297 mm;
- Margins: right and left – 25 mm, top and bottom – 20 mm;
- Font 15 pt;
- Line spacing – 1,25;
- Word-spacing – 1 character;
- Paragraph – 1,25, should be the same for the whole text;
- Text-align – justify;
- Abbreviations – conventional;
- References are to be put in square brackets according to GOST P 7.0.100-2018.

**The file name** should include the family name of the author and the short name of the HE institution, e.g.: Smirnova\_paper\_TSU.doc and Smirnova\_application\_TSU.doc
